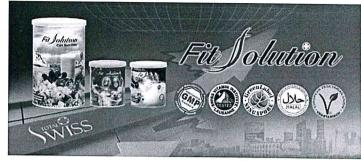
Evaluation Labels and Certificates on Total Swiss Products

As mentioned in the last report Total Swiss promotes his Fit Solution products with various labels. Mostly the following labels are applied.

- European Vegetarian Union
- Halal (ifanca)
- Green Label Singapore
- Swiss Vitamin Lausanne
- GMP



European Vegetarian Union

It has already been confirmed that the label of the European Vegetarian Union label that is applied on Total Swiss' "Vegetarian Protein Powder" is used illegally. Mr. Pichler explained that he tried to contact Total Swiss before, however he did not receive any response. He said that within Europe they generally take effective actions against the illegal use of their label, however in Asia they are still growing and therefore do not have the budget and in some jurisdictions not even the proper right basis for enforcement.

Mr. Pichler first thought we have direct contact to Total Swiss and provided us with a warning letter. Please refer to the next page to the warning letter issued for Total Swiss' Hong Kong company. We are currently waiting for the official confirmation of the Country Coordinator & V-Label CEO Mr. Renato Pichler.

We double checked whether other products of Total Swiss bear the V-Label. However, it was only confirmed for the "Vegetarian Protein Powder" carries the V-Label. Fit Solution Lutein Nano carries a different kind of vegetarian label of which we assume that it was created by Total Swiss themself. The relevant labels are encircled in the below pictures.

European V-Label use

We found out that you use the registered trade-mark «V-Label»:



This label can only be used from licensees with a valid certificate.

Because you are not a licensee, your use is illegal.

If you will still use the label in the future, we have to take legal action against your company.

But first we will give you the chance to solve this problem with one of the 2 possibilities:

- 1. Remove the V-label from all your products and your homepage until 1 October 2016
- 2. Certify your products

If we don't get any reaction from you until 1 October 2016, we will forward this case to our lawyer.

Halal (ifanca)

We are waiting for a response from ifanca. The fraudulent use of the label by Total Swiss still has not been reported on the ifanca's website as of September 9, 2016.

Indonesien: Umsetzung des neuen Halal-Gesetzes

Verpflichtende Produktkennzeichnung in vielen Bereichen

Im September 2014 wurde in Indonesien ein Halal-Gesetz (Gesetz Nr. 33/2014) erlassen, welches schrittweise bis 2019 voll in Kraft treten soll. Das Gesetz betrifft die Produktgruppen Nahrungsmittel und Getränke, pharmazeutische Produkte, Kosmetika und Lederwaren unmittelbar und – da es sehr weit auslegbar ist – potentielle auch noch eine Vielzahl anderer Branchen.

Bis spätestens 2019 müssen alle in Indonesien im Umlauf befindlichen Produkte verpflichtend als "halal" (den islamischen Vorschriften entsprechend) bzw. "nicht-halal" zertifiziert und gekennzeichnet werden.

Die Umsetzung des Gesetzes erfolgt in Etappen und folgende Waren sind ab dem jeweiligen Datum zu zertifizieren:

- Ab 1 November 2016: Nahrungsmittel und Getränke
- Ab 1 November 2017: Kosmetik, chemische Produkte und gentechnisch veränderte Güter
- Ab 1 November 2018: Pharmazeutische und biologische Erzeugnisse

Für die Nichteinhaltung der Vorgaben sieht das Gesetz empfindliche Strafen bis hin zu Freiheitsstrafen vor. Produzentenvertreter zeigen sich besorgt über die potentielle Tragweite der Bestimmungen.

Green Label Singapore

As explained in the last report. Total Swiss is legally using the Green Label Singpore on its rather newly introduced products such as laundry detergent etc. We are currently checking if the promotion of this label on several websites so that consumer get the impression also Fit Solution products carry that label can be reported as a consumer misleading behavior.

Swiss Vitamin Lausanne

It has been confirmed that Total Swiss has been certified by the Swiss Vitamin Lausanne institution.

Good Manufacturing Practice - GMP

As the Total Swiss suppliers do not show a specific GMP Logo and do not disclose the certifying authority, it is very difficult to check which company has certified the GMP status. Several hundred different GMP logos can be found online so it is questionable whether it is allowed to create a different one or not.

Additionally there is no clear structure how the transnational label works, which companies are allowed to certify and, if there are different requirements for each country.

Further Claims

World Halal Council (WHC)

Total Swiss claims that the company is a WHC certified company but does not say that any products are WHC certified. Therefore it is not necessary to check if one the WHC members certified Totals Swiss' products. At the moment the verification whether the WHC certifies whole companies or not is work in progress.

On the World Halal Council website is written that not only food products can be certified. Moreover, packages and other materials which are used in the value chain can be certified as well. Until know there is no indication that the WHC certifies whole companies and Total Swiss is also not a member of the WHC.

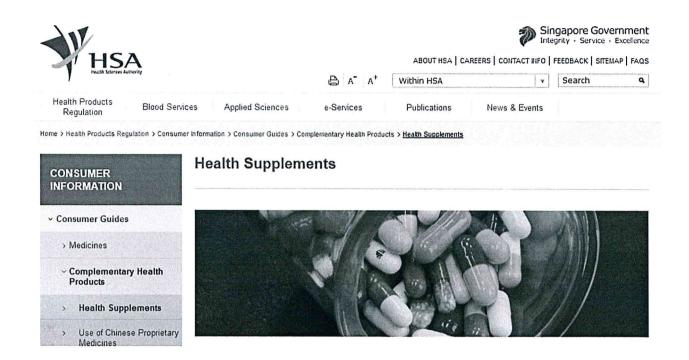
Health Science Authority (Singapore)

On some offerings, such as the newly reported offering at the Free Web Store Website (https://www.freewebstore.org/total-swiss-products), Total Swiss promotes it products claiming that they have been approved by the Health Sciences Authority (HSA) in Singapore (see below).



However, on the website of HSA (http://www.hsa.gov.sg) it is in the consumer information on health supplements clearly stated that "HSA does not provide any assessment or approval for health supplements". Please refer to the following link and the screenshots below:

"Detoxify your body"

Products that claim to "detoxify your body" do not have scientific evidence to support such claims. These products usually contain natural ingredients that work by promoting water loss or stimulating bowel movements. As such, "detoxification products" may not always be safe and suitable for everyone. In some individuals, this water loss causes fluid and electrolyte imbalance which can lead to adverse effects such as headaches, fatigue and dehydration. Stimulating bowel movements may cause gastro-intestinal cramps and long-term use of products that cause such laxative effects can potentially lead to a decreased bowel function and dependency. These products should not be consumed on a long-term basis. Individuals on medications or with existing medical conditions such as diabetes should consult their doctors before using such products.

"Anti-stress" or "Reduce Stress"

Stress is a result of strain or tension resulting from demanding circumstances. Health supplements do not reduce or prevent stress, and therefore this claim is misleading.

"HSA Approved"

HSA does not provide any assessment or approval for health supplements. The responsibility of ensuring the safety and/or quality of health supplements rests on the dealers.

In summary, while HSA has in place a post-market surveillance programme to monitor the safety of health supplements, you are advised to make informed decisions and exercise discretion in your purchases and use of your health supplements.

What Should I Do When Problems Arise?

If you suspect that the health supplement you are taking makes you unwell, see your doctor or pharmacist immediately.

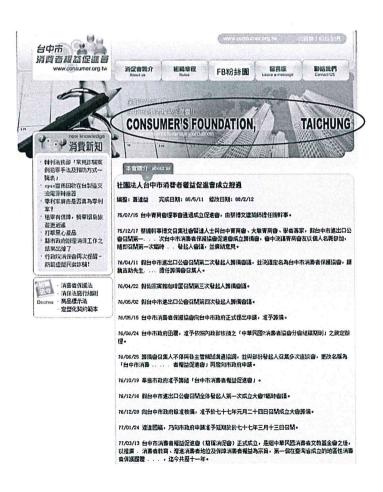


National Excellent Commodity Gold Award

In Hong Kong Total Swiss (http://www.totalswiss.com.hk) is also claiming that Fit Solution products have been evaluated by "Consumer's Foundation, Chinese Taipei" with a label called "National excellent commodity gold award".



According to the Consumer's Foundation (Taichung, Taiwan) http://www.twconsumers.org/index.htm this award has no government credibility and confuse consumer. For the recommendations of the Consumer's Foundation Taichung (http://www.twconsumers.org/990521.pdf) please refer to translated text on the next page (highlights have been added).



Recommendations:

Purpose: to prevent the evaluation called "National excellent commodity gold award" for goods and service of business operations by "Consumer's Foundation, Chinese Taipei" and to promote a correct consumption concept.

Note: Sometimes consumers call us to ask something about the "National excellent commodity gold award", whether this award from the government's accreditation certification. So the legal basis, the evaluation system and credibility of this evaluation are confusing. And whether the award attached goods accord with national quality assurance is also a question.

Recommended items are as follows:

- (1) Consumer's Foundation, Chinese Taipei should follow the principles of Consumer protection organization and should not confuse the consumer and business operators.
- (2) Consumer should know that the "National excellent commodity gold award" has no national government credibility
- (3) The evaluated companies and products should be canceled and they should not use gold award for advertisement.
- (4) The Executive Council and the Ministry of internal affairs should publish this information in the official website
- (5) Other groups, who have the consensus to protect consumer right, can work together to disclose that information and publish in their official website.
- (6) Executive consumer protection helps the legitimate consumer protection groups for investigation on goods and service to disclosure illegal activities.
